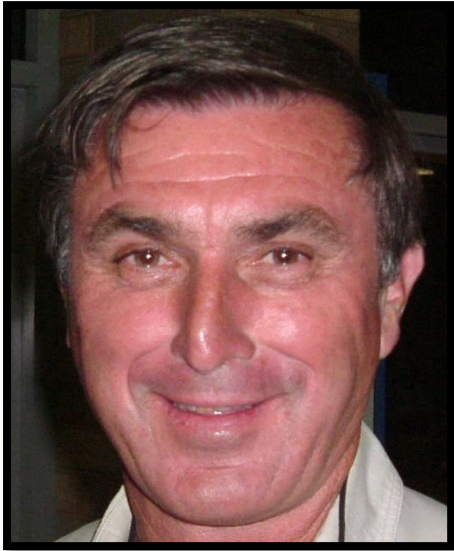


JOHN PATRICK NILON

Michael is a current DIRECTOR of the Club.

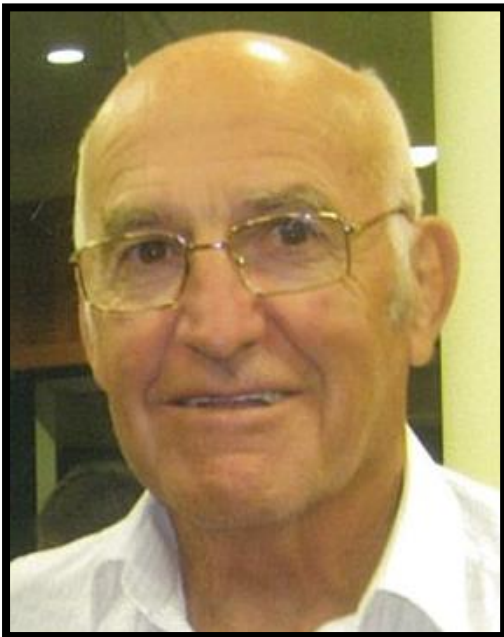
Michael has been a Member of the Club since 2006.
